**NOTIFICATION**

**ENTRY AND TESTING PROTOCOLS**

Dated Shillong, the 7<sup>th</sup> December, 2021

**No.Health.99/2020/174: The following protocol shall be applicable for Constitutional Dignitaries and Officials of the Government of Meghalaya engaged in important official works.**

**1. INTERNATIONAL ARRIVALS**

- 1.1. It is mandatory to fill up the Self-Declaration Form (SDF) and uploading of negative RTPCR test report for all international travellers as per notification from the Ministry of Health and Family Welfare, Government of India dated the 28<sup>th</sup> November, 2021.
- 1.2. RT-PCR Testing at Entry is mandatory for all Dignitaries and Officials coming from countries at risk such as Countries in Europe including The United Kingdom, South Africa, Brazil, Botswana, China, Mauritius, New Zealand, Zimbabwe, Singapore, Hong Kong, Israel as notified by Ministry of Health and Family Welfare dated 28th November, 2021.
- 1.3. If tested negative, the traveller shall be at home or institutional quarantine for 3 days. Retesting shall be done by the concerned officials of District Surveillance Unit on the 3rd day and if negative, self health monitoring by the Dignitary/Official shall be allowed for resuming their Government business. However, they shall follow COVID appropriate behavior at all times.
- 1.4. If tested positive on a repeat testing, sample shall be sent for genomic testing.

**2. DOMESTIC TRAVELLERS**

- 2.1 The Entry exit protocol remains the same for the rest of the travellers as per notification issued by Department of Health and Family Welfare, Government of Meghalaya on 6<sup>th</sup> September, 2021.

All the Dignitaries and Officials of the State or Visiting the State are advised to follow the Covid Appropriate Behavior at all times which includes wearing mask, maintaining social distance and frequent sanitization of the hands.
