NOTIFICATION

Protocol for RAT Testing in Home Deaths.

Any person who is declared dead in a place other than a Medical Institution, such as the residence of the deceased or other places, may be tested through Rapid Antigen Test (RAT) to ascertain the cause of the death and confirm COVID 19 infection. The District Surveillance Team or the Medical Officer of the closest health facility may decide the course of action relating to the testing of the dead body. If the dead body is found to be COVID Positive, then the dead body management is also to be done at the site by the concerned health authority as per the requisite protocols.

The following shall be considered as criteria for testing a deceased person for COVID 19.

- 1. Symptoms
 - FeverCoughBreathlessness
 - Loss of AppetiteGeneral Weakness
 - Diarrhea

- 2. If the deceased had recently been in contact with a positive COVID-19 person and had been classified as a high risk contact.
- 3. If any of the family members is/was positive for COVID-19.
- 4. If there is clustering or high transmission of the infection in the locality where the deceased resided or the area falls under Containment Zone.

The Medical Officer shall advise the family members to get tested under such circumstances and counsel them on the necessity to do so. The collection of samples may be done at the residence of the deceased/wherever the body has been kept/at the nearest health facility as per the local situation/convenience.

This may be adopted as a part of the protocol for dead body management in the context of home deaths, irrespective of the cause of the death.
