APPLICATIONS FOR MEDICAL STUDIES AGAINST STATE QUOTA SEATS, 2019-2020

Applications are invited in prescribed form for Medical Studies i.e. MBBS/BDS/BHMS/BAMS/BASLP against State Quota of seats in various Medical Institutions in India during academic session 2019-2020 and will be received in the Office of the Director of Health Services (MI), Shillong and District Medical & Health Officer, West Garo Hills District, Tura.

(N.B. Application form will be issued from <u>27th May</u>, <u>2019</u> to <u>14th June</u>, <u>2019</u> during office hours in the above offices).

1. (i) Only candidates who are indigenous inhabitants or permanent residents of the State and have passed 10+2 level from a recognized University, Board of Authority in the subjects of Physics, Chemistry, Biology/Biotechnology and English and qualifying NEET UG 2019 are eligible to apply. A candidate who is appearing in the qualifying examination i.e. 10+2 (Science) in 2019 whose result is awaited may apply but he/she shall not be eligible for admission for MBBS/BDS/BHMS/BAMS/BASLP if he/she does not pass the qualifying examination at the time of Screening by the Committee.

However, and subject to production of a Permanent Resident Certificate,

- (ii) the Children of the Employees of the Central Government, other State/ UT Government who are on deputation to Meghalaya and
- (iii) the Children of the employees of the Central Government, All India Services, other State/ UT Government posted in and having Headquarter within Meghalaya will also be eligible to apply, provided they fulfill conditions at (i) above.
- 2. Candidates applying for MBBS/BDS/ BHMS/BAMS/BASLP Course should complete the age of 17 years at the time of admission or will complete the age on or before the 31st December of the year of his/her admission to 1st Year MBBS/BDS/ BHMS/BAMS/BASLP Course. The upper age limit for candidates is 25 years as on 31st December of the year on which they proceed for MBBS/BDS/BHMS/BAMS/BASLP course. However, provided that this upper age limit shall be **relaxed by 5 years for the candidates of SC/ST**.
- **3.** Selection of candidates who are otherwise medically fit and eligible will be made purely on the basis of merit after a candidate obtained qualifying percentile in National Eligibility Entrance Test (NEET) UG 2019 to MBBS/BDS/ BHMS/BAMS/BASLP course held for the academic session 2019-2020. In respect of candidates belonging to Scheduled Castes, Scheduled Tribes, the minimum marks

shall be as prescribed to such categories and subject to Reservation Policy of the State Government applicable in this regard.

4. Applications may be submitted offline only.

Offline Applications:

Application Form may be obtained from the office of the Director of Health Services (MI), Meghalaya, Shillong and the District Medical & Health Officer, West Garo Hills, Tura against submission/production of a Demand Draft (Nationalised Bank) of Rs. 250/- (Rupees Two hundred and Fifty) only and Rs. 100/- (Rupees One hundred) only in the case of ST/SC payable to the Director of Health Services (MI), Meghalaya, Shillong.

COMPLETED APPLICATION FORMS WILL ONLY BE ACCEPTED IN THE OFFICE OF THE DIRECTOR OF HEALTH SERVICES (MI) AT SHILLONG AND THE DISTRICT MEDICAL & HEALTH OFFICER, WEST GARO HILLS, TURA.

- **5.** Candidates must note that after submission of the Application Form it cannot be withdrawn. Claims for refund of Application fee will not be entertained.
- 6. Application Form received after 4:00 P.M. on 14th June, 2019 and without NEET UG 2019 Result Sheet will not be considered under any circumstances including postal delay etc.
- 7. ELIGIBLE APPLICANTS ARE REQUIRED TO APPEAR BEFORE A SCREENING COMMITTEE FOR VERIFICATION OF ORIGINAL COPIES OF 10 AND 10+2 LEVEL, NEET UG 2019 (RESULT SHEET) ADMIT CARDS, MARK SHEETS, ST/SC CERTIFICATE, PERMANENT RESIDENTIAL CERTIFICATE (PRC), CHARACTER CERTIFICATE FROM INSTITUTION LAST ATTENDED AND CERTIFICATE OF HAVING PASSED THE QUALIFYING EXAMINATION IN SCIENCE STREAM AT THE TIME OF APPEARING THE INTERVIEW OF SCREENING. ALL THE ORIGINAL CERTIFICATES MENTIONED SHOULD BE MADE AVAILABLE. THE APPLICANTS WILL ALSO HAVE TO APPEAR BEFORE THE MEDICAL BOARD. DATES TO BE NOTIFIED LATER.
- 8. The final list of applicants selected for nomination under all categories and the waiting list for each such category will be published in the Notice Board of the Directorate of Health Services (MI). It will also be published in the local dailies published from Shillong and Tura. All applicants are required to ascertain the nominations from the above sources. NO INDIVIDUAL INTIMATION WILL BE SERVED ON ANY APPLICANT SELECTED FOR NOMINATION.

- 9. Applicants whose names are included in the list selected for the nomination and published as above are required to report to the Under Secretary to the Govt. of Meghalaya, Health & Family Welfare Department, Room No. 506, Additional Secretariat Building within the date and time to be indicated while publishing the list of selected candidates and personally submit their letter of acceptance, execute Surety Bond for the value of Rs. 30,00,000/- (Rupees Thirty Lakhs) only (in case of MBBS Course) with 5(five) years rural service and to collect their letter of nominations for further instructions, as the case may be. ANY SELECTED APPLICANT, WHO FAILS TO REPORT ACCORDING TO THE FIXED DATE AS SPECIFIED ABOVE, WILL AUTOMATICALLY LOSE HIS OR HER RIGHT TO NOMINATION AND THE NEXT ELIGIBLE CANDIDATE FROM THE WAITING LIST WILL BE NOMINATED.
