Provided however that if the Student is desirous of continuing Post Graduate medical studies, such notice shall expressly specify such desire and request for permission of the Government to continue such Post-graduate studies, and it shall be open to the Government in its absolute discretion to refuse such permission, or to grant such permission subject to the condition that the student shall within 30 (thirty) days from the date of completion of such Post-graduate medical course, give like Notice to the Government in the manner specified above.

When called upon by the Government at any time within a Period of twelve

months from the date of receipt of Notice from the Student as aforesaid, JOIN THE MEGHALAYA HEALTH SERVICE and serve anywhere in the rural areas, however posted by the Government for a minimum period of 5(five years) at such remuneration as may be prescribed therefore, and, in such event to discharge such duties as may be assigned to him/her by the Government or his/her Superior with utmost diligence and efficiency and shall observe the rules for the time being in force regulating the conduct of persons so serving.

NOW THIS BOND is executed with the condition that if the Student fully discharges the above mentioned terms and conditions, then this Bond-cum-Agreement shall be void and

ineffective from the date upon which they fully discharge of the above mentioned terms and conditions is completed, that is the date on which he/she completes 5(five) years of service in the rural areas, otherwise this Bond-cum-Agreement shall continue to remain effective and in full force until fully discharged by the Student.
