
NOTIFICATION

Dated Shillong, the 10th July, 2020.

No. Health.68/2020/72: In exercise of the powers conferred under Section 2, 3 and 4 of the Epidemic Diseases Act, 1897, the Governor of Meghalaya is pleased to make the following regulations to amend the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020, namely;-

1. (1) These Regulations may be called the Meghalaya Epidemic Diseases, COVID-19 (Fifth Amendment) Regulations, 2020.

(2) It shall come into force from the date of its notification in official Gazette.
2. Insertion of new regulation 2A after existing regulation 2;
"2A. "Public Place" in this regulation shall mean any enclosed indoor area used by the general public or serving as a place of work containing two hundred fifty or more square feet of floor space, including, but not limited to, all restaurants, all retail stores, lobbies and malls, offices, including waiting rooms, and other commercial establishments; public conveyances; educational facilities; hospitals, clinics, nursing homes, and other health care and medical facilities; and auditoriums, elevators, theaters, libraries, art museums, concert halls, indoor arenas, and meeting rooms, as well as outdoor areas of market places, public roads, sports stadiums or fields."
3. Amendment of Regulation 20: Existing Regulation 20 shall be substituted as follows;
"20. Penalty: (1) A fine of rupees five hundred for first offence and rupees one thousand for subsequent offences, shall be imposed on any person or institution or organisation, found violating any provisions of this regulations or any orders issued by the Government under these regulations, as per procedure notified in the official Gazette, by the designated Officer notified under Section 2 of the Epidemic Diseases Act, 1897.
(2) Any person or institution or organisation violating any provisions of these regulations shall be deemed to have committed an offence punishable under Section 188 of the Indian Penal Code (45 of 1860) and shall be proceeded accordingly.
4. Insertion of new regulation 19A after existing regulation 19;
"19A. Authorised persons at the State, District and Village level shall assist in reporting the violation of the provisions of the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020 to the designated Officers."
5. After Regulation 20, the paragraphs appearing as Regulations 18 and 19 shall be renumbered as Regulations 21 and 22.
6. Notwithstanding such amendment, anything done or any action taken under the earlier provisions, before the amendment, shall be deemed to have been done or taken under the provisions of these amendment Regulations.





No. Health.68/2020/73:- In exercise of the powers conferred under Regulation 20 (1) of the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020 the Government of Meghalaya is pleased to notify the procedure to be followed for imposition of fine for violation of the provision of the Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020, as follows,-

1. Penalty to the violators, under the aforesaid provision shall be imposed by the designated Officers, who have been empowered under Section 2 of the Epidemic Diseases Act, 1897.
2. Receipt of the fine imposed shall be issued as per CHALLAN annexed at ANNEXURE – I.
3. The fine received shall be deposited to the head of account “other receipt” under Health and Family Welfare Department.


