

Order

In view of COVID-19 pandemic there is an urgent need to put in place a protocol for truck drivers/handyman entering the State for transporting essential commodities to be duly followed as follows: -

1. They are to be provided with masks and hand sanitizers.
2. Registration at entry point – Full name, Address, Contact Number, Travel history for the last 14 days and if having any symptoms of fever, cough, breathing difficulty, to immediately be transferred to the nearest health facility.
3. To provide the name, address & phone number of owner/agency.
4. IEC materials in Hindi/Khasi are to be handed over to them and they are to follow the advisory of hand hygiene, cough etiquette and social distancing.

This supersedes this Department's Order No.Health.94/2020/16 dated 7th April, 2020.
