The Officer will have to execute a bond, if not executed, that they will come back to serve the State and in case of resignation within 5 (five) years after completion of the course, they shall be required to refund the entire expenditure borne by the Government including Salary, T.A/D.A, Fees, etc for the period during their Study Leave.
3. The Officer shall provide her email ID/Address for communication and shall intimate change(s), if any, in his email ID/Address from time to time. The Officer would have continued to hold the post but for his/her proceeding on leave and there is every likelihood of his/her returning to the same post and place from which he/she proceeded for the Post Graduate study.
