AGAINST STATE QUOTA SEATS**

Online Application in prescribed format for Medical Studies i.e. **(1) MBBS (2) BDS (3) BHMS (4) BAMS (5) BUMS (6) BASLP** against State Quota seats in various Medical Institutions in India during Academic Session 2024-2025 is hereby invited with effect from **6th to 21st August, 2024 (till 5:00 PM)**. Eligibility for Medical Studies:-

1. Only candidates who are **indigenous inhabitants or Permanent Residents of the State** and have passed 10+2 level examination from a recognized University or Board of Authority in the subjects of **Physics, Chemistry, Biology / Biotechnology and English and qualifying NEET UG 2024** are eligible to apply.
2. For the purpose of permanent residency status in respect of admission in higher education institutions, the instructions of Political Department including Order No. POL. 97/74/174 dated 10th June 1983 and No. POL.97/74/Pt-1/221 dated 21st March 2014 shall be referred to.
3. They should complete the age of 17 years on or before 31st December, 2024. The upper age limit for candidates is 25 years as on 31st December 2024. However, this upper age limit shall be **relaxed by 5 years for the candidates of Meghalaya belonging to ST / SC / OST.**
4. Applicants should be medically fit.
5. Application Form without **NEET UG 2024 (RESULT SHEET)** will not be considered under any circumstances.
6. **No application will be accepted or entertained after the last date of submission.**
7. **Selection of candidates:**
 - (i) Candidates who are otherwise medically fit and eligible will be ranked on merit as per their NEET Score in their respective categories.
 - (ii) In respect of candidates belonging to Scheduled Castes/Scheduled Tribes, the minimum marks shall be with reference to marks secured by candidates in the respective categories.
 - (iii) Final selection of eligible candidates shall be subject to Reservation Policy of the State of Meghalaya.

- (iv) In case of a tie, NEET marks in the following subjects and order - Biology, Chemistry and Physics - will be considered:
- (a) Candidate with higher marks in Biology will be given the first preference.
 - (b) After Biology, the next determining factor is the marks obtained in the Chemistry. Candidates with higher marks in this subject are given preference in the tie-breaking process.
 - (c) If the tie still exists, then the candidate having higher marks in Physics will be given preference.
8. The list of candidates eligible for screening / counselling will be displayed in the website above.
9. The date for screening / counselling will be notified later in the Government website.

Final list of applicants:

- (i) The candidates will be ranked on merit as per their NEET score but in their respective categories.
 - (ii) The names of candidates selected for nomination under all categories and the waiting list for each such category will be displayed in the Notice Board of the Directorate of Health Services (MI), Meghalaya, Shillong / Office of the District Medical & Health Officer, Tura, West Garo Hills and in the Government website. It will also be published in the local dailies published from Shillong and Tura. All applicants are required to ascertain the nominations from the above sources. **NO INDIVIDUAL INTIMATION WILL BE SERVED ON ANY APPLICANT SELECTED FOR NOMINATION.**
10. Applicants whose names are included in the list selected for the nomination and published as above are required to report to the Deputy Secretary/ Under Secretary to the Government of Meghalaya, Health & Family Welfare Department, Room No. 506, Additional Secretariat Building within the date and time to be indicated while publishing the list of selected candidates and personally submit their letter of acceptance, execute Surety Bond for the value of Rs.30,00,000/- (Rupees Thirty Lakhs) only (in case of MBBS Course) with 5 (five) years Rural service according to the Categories and to collect their letter of nominations for further instructions, as the case may be. **ANY SELECTED APPLICANT, WHO FAILS TO REPORT ACCORDING TO THE FIXED DATE AS SPECIFIED ABOVE, WILL AUTOMATICALLY LOSE HIS OR HER RIGHT TO NOMINATION AND THE NEXT ELIGIBLE CANDIDATE FROM THE WAITING LIST WILL BE NOMINATED.**

11. Terms and conditions for admission and all other requirements including recurring fees of the concerned Medical Institution to which the applicant is nominated will have to be abided and paid by the applicant concerned in time and the responsibility on this count shall rest with the candidate / student.

- (i) The list of Medical Colleges allotted to the State will be shared with all the eligible candidates for indicating their preference in descending order.
- (ii) Counselling will be done based on the preferences provided by the candidates.
