- (ii) **Category II:** NRI/Children of NRI who originally belong to an Indian State other than Meghalaya.
- (iii) Under this policy Non-Resident Indian means a person of Indian origin, whether holding an Indian Passport or Foreign Passport, who is either permanently or temporarily settled outside India and in either case:
  - a) for or on taking up employment outside India, or
  - b) for carrying on a business or vocation outside India; or
  - c) for any other purpose, in such circumstances, as would indicate his intention to stay outside India for an uncertain period;
  - d) for ascertaining the eligibility relevant documents including Foreign Country Passport or Green Card or Permanent Resident Card or Proof of Residency of Foreign country issued by competent authority or OCI/PIO Card issued by the Government of India shall be taken into consideration.
