4) **SUBMISSION OF APPLICATION:**

Candidates are required to register, apply and upload the necessary information before submitting their applications **Online** after which the applicants are to pay the Application fees of ₹460/- (Rupees Four Hundred and Sixty) only and ₹230/- (Rupees Two Hundred and Thirty) only for SC/ST candidates. Applications received through any other mode will not be accepted and will be summarily rejected.

It is mandatory for the applicants to upload a valid Meghalaya Nursing Council Registration at the time of applying. Further, in order to minimize the duration of document verification process, candidates who opted for sports person category are to upload the sports related document at the time of filling the online application form. Pre-screening of the uploaded documents will be done by the competent authority.

5) **GENERAL INSTRUCTIONS:**

- Applicants are to apply well in advance before the closing date. The last date of application is on or before **09th November, 2025 midnight**.
- Issue of appointments by the appointing authority will be given based on vacancies available.
- Applicants must upload a recent photograph on the space provided in the application.
- Admit Card will be available for download from the portal **mmsrb.in**. Candidates have to use their log-in ID and click on **my application>download admit card**.
- Documents to be produced in original as well as Xerox copy (self-attested) during physical verification are listed below:
 - Valid Registration Certificate under Meghalaya Nursing Council **registered at the time of applying for the post**
 - Birth Certificate **or** SSLC Admit Card
 - Scheduled Tribe Certificate / Scheduled Caste Certificate issued by competent authority of Government of Meghalaya.
 - Diploma Certificate for ANM or higher qualifications from Institution recognized by Indian Nursing Council.
 - Mark Sheet(s) last passed from Nursing Institute recognized by Indian Nursing Council.
 - Proof of identity/Residency: Epic/Aadhaar Card/ Driving License.
 - Sports Certificates for sports persons as per O.M No. PER(AR)150/88/534, Dated 7/8/2017.
- The final appointment after selection is subject to satisfactory Police Verification Report as per existing norms.

6) SCHEME OF EXAMINATION

- A. Syllabus -** The syllabus for the written examination will be as per Indian Nursing Council (INC) Syllabus.
- B. Mode of Examination-** The Written Examination is a Pen & Paper-based Test, to be answered on the specially designed machine gradable OMR sheet using **Black Ball Point Pen**. Moreover, tampering with the OMR sheet at any stage will lead to declaration of candidates as unsuccessful.
- C. Pattern of the Examination –**
- a) The Maximum marks for the Written Examination will be 100 marks and **the minimum Pass Marks will be 30 marks.**
 - b) Questions will be in Multiple Choice Questions.
 - c) Each question will carry 1 mark.
 - d) There will be NO NEGATIVE MARKING for attempt of questions.
- D. Medium of the Question Papers –** The Written Examination will be in English medium.
- E. Centres:** There will be two separate Centres for writing the Examination, i.e. at **Shillong** and **Tura**.

7) METHOD OF SELECTION:

The final selection list against vacancies notified in this advertisement shall be made by the Meghalaya Medical Services Recruitment Board. The process of selection shall be made based purely on merit from the marks obtained by the candidates in the Written Examination.

8) DECLARATION OF RESULTS:

- A.** The list of appearing candidates along with the Marks obtained will be declared shortly after validation of the OMR Response Sheet which will be made available on the website, portal and local newspaper.
- B.** The list of candidates based on merit of the written examination as per the approved Reservation Roster will be declared for document verification. The date for the document verification will be intimated later. Mere appearance of a candidate's name on the list of successful candidates prior to satisfactory verification of documents does not necessarily qualify for appointment to the post.
- C.** Final Selection of successful candidates for the post will be subject to satisfactory verification of all original documents to be brought along in person for physical verification.

9) DEBARMENT:

Candidates should make sure of their eligibility for the post applied and that the self-declaration made by them in the format of application regarding their eligibility is correct in all respects. Any candidate providing incorrect information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable TO BE DEBARRED FROM APPEARING FOR ANY OF THE EXAMINATIONS CONDUCTED BY THE MMSRB, and summarily their candidature for this recruitment will be rejected.
