Whereas, the MMSRB had issued the Advertisement vide letter No. HSM/MMSRB/REC/ANM/8/25/333 Dated Shillong, the 24th October, 2025 inviting Online application for recruitment to the post of Auxiliary Nurse Midwife (ANM).

Whereas, the MMSRB has conducted the written examination for recruitment to the posts of ANM on the 29th November, 2025.

- The mere appearance of the candidate Roll No. in the list for document verification does not confer them the right to claim for the post as they shall be subjected to satisfactory verification of documents.
- Any aggrieved candidates may directly reach out to the Grievance Redressal Cell of the MMSRB through formal complaint in petition or through mail at mmrbdhsmimegh@gmail.com. up to 9th December, 2025. Any complaints after the mentioned date will not be entertained.
- **If 2 (two) or more candidates have secured equal marks in the written examination, the order of merits in respect of such candidates shall be fixed on the basis of their age (the person or persons older in age being placed higher in the order of merit).**
- If during the process of Document Verification of the listed candidates, some of the documents are found missing or not in order, then a window period of 72 (Seventy-Two) hours will be given to the candidate(s) to correct the discrepancy. No documents will be accepted after the 72 (Seventy-Two) hours have elapse.
