#### **NOTIFICATION**

Whereas, the MMSRB had issued the Advertisement vide letter No. HSM/MMSRB/REC/ANM/8/25/333 Dated Shillong, the 24th October, 2025 inviting Online application for recruitment to the post of Auxiliary Nurse Midwife (ANM).

Whereas, the MMSRB has published the list of all candidates with marks obtained and the list of Notification candidates eligible appearing the Document Verification vide No.  $4^{th}$ HSM/MMSRB/REC/ANM/8/25/435, Dated Shillong, the December. 2025 and HSM/MMSRB/REC/ANM/8/25/436, Dated Shillong the 4<sup>th</sup> December, 2025.

Whereas, the Grievance Redressal Cell received 16 (sixteen) applications during the stipulated time allotted. All the grievances were addressed and cleared by the Grievance Redressal Cell in consultation with Law Department and Expert Agency.

Whereas, the Document Verification was suspended vide Notification No. HSM/MMSRB/REC/ANM/8/25/460, Dated Shillong the 8<sup>th</sup> December, 2025until further notice.

Whereas, the Expert Agency has pointed out the following observations:

i) There was a wrong mapping of answer key uploaded in the website for question No. 73 (Set A), 75 (Set B) and 35 (Set C).

Now therefore, in view of the above observation and keeping in line with the principles of natural justice, the Board in its effort of ensuring a fair and transparent conduct of the recruitment process, has decided on the following important consideration:

1. A grace mark of 1 mark was given to all candidates whose answer are shown wrong for the question at i) above during the initial evaluation of OMR Response sheet by the system. However, no mark will be given to those who did not attempt or had given multiple response.

In view of the above and after satisfactory settlement of all grievances, the list for document verification has been updated accordingly and uploaded in the website www.meghealth.gov.in

The date for **DOCUMENT VERIFICATION** will be intimated later. The eligible candidates must bring along the documents as specified in the Advertisement in Original as well as in duplicate copy. The candidates will be called in descending order as per the vacancies advertised.

### **IMPORTANT – PLEASE NOTE:**

- THIS IS NOT A PERSONAL INTERVIEW OR FINAL RESULT. THIS IS FOR THE PURPOSE OF VERIFICATION OF ORIGINAL DOCUMENTS ONLY.
- If 2 (two) or more candidates have secured equal marks in the written examination, the order of merits in respect of such candidates shall be fixed on the basis of their age (the person or persons older in age being placed higher in the order of merit).
