1. During the period of Study Leave, the Officer(s) shall draw salary equal to the pay without any allowance except DA, as provided under S.R. 103(2)(a) of the Meghalaya FRs & SRs, 1984.
2. The Officer(s) will have to execute a bond, if not executed, that they will come back to serve the State and in case of resignation within 5(five) years after completion of the course, he/she shall be required to refund the entire expenditure borne by the Government including Salary, T.A/D.A, Fees, etc, for the period during their Study Leave.
3. The Officer(s) shall provide his/her email ID/Address for communication and shall intimate change, if any in his email ID/address from time to time. The Officer(s) would have continued to hold the post but for his/her proceeding on leave and there is every likelihood of his/her returning to the same post and place from which he/she proceeded for the Post Graduate study.
