The grant of Study Leave shall be subject to the following conditions:

1. During the period of Study Leave, the Officer shall draw salary equal to the pay without any allowance except DA, as provided under S.R. 103(2)(a) of the Meghalaya FRs & SRs, 1984.
2. The Officer will have to execute a bond, if not executed, that she will come back to serve the State and in case of resignation within 5(five) years after completion of the course, she shall be required to refund the entire expenditure borne by the Government including Salary, T.A/D.A, Fees, etc, for the period during her Study Leave.
3. The Officer shall provide her email ID/Address for communication and shall intimate change, if any in her email ID/address from time to time. The Officer would have continued to hold the post but for her proceeding on leave and there is every likelihood of her returning to the same post and place from which she proceeded for the Post Graduate study.


